VTT ENROLLMENT CONTRACT - 2012/2013

guardian(s) (the "Parents") agree to the follow	ving terms and conditions for the Enrollment of

Enrollment and Tuition Deposit

- 1. The Parents agree to submit to VTT on or before February 23, 2012 by 3:00pm:
 - i) a signed copy of this Enrollment Contract for each Student to be enrolled;
 - ii) a completed and signed Enrollment Form or Student Re-enrollment Short Form for each Family to be enrolled;
 - iii) Completed Tuition Calculation Form;
 - iv) Student Medical and Field Trip Consent and Waiver Form for each Student to be enrolled:
 - v) Completed Tuition Assistance Application Form (for those families who require it);
 - vi) a non-refundable tuition deposit (the "Deposit") for each Student to be enrolled. The Deposit is payable by cheque to the "Vancouver Talmud Torah Association;"
 - vii) a Parent Participation Program cheque payable to VTT in the amount of \$300 and post-dated to June 26, 2013 for each Family to be enrolled in the 2012/2013 school year.
- 2. Upon timely receipt (on or before February 23, 2012) of a signed copy of this Enrollment Contract, a fully completed and signed Enrollment Form, the Deposit(s) and other documentation mentioned above, VTT will reserve a position in our school for the Student for the 2012/2013 school year.
- 3. The Deposit amount to be paid for each Student is set out in the following table:

Level	Deposit Amount
Preschool	\$ 500
Kindergarten	\$ 750

Grade 1-7	\$ 1,000

- 4. VTT will apply the Deposit to the annual tuition (the "Tuition") assessed for the Student.
- 5. The offer of Enrollment and this Enrollment Contract is for the 2012/2013 school year only. Any offers of Enrollment for future school years are at the sole discretion of VTT.

Late Enrollment

- 6. If VTT does not receive a signed copy of this Enrollment Contract, a fully completed and signed copy of the Enrollment Form, the Deposit and other documentation mentioned above, for a Student by 3:00pm on February 23, 2012, VTT may, at its sole discretion, refuse to hold a space for the Student for the 2012/2013 school year.
- 7. VTT may, at its sole discretion, elect to accept Enrollment documentation and deposits after February 23, 2012. Any Enrollment documentation and deposits mentioned above, submitted after February 23, 2012, will require payment of the Deposit(s), and an additional late processing fee of \$250.00 per student. In these circumstances, the Parents agree to pay any unpaid Tuition for the 2012/2013 school year owing to date.
- 8. The late Enrollment processing fee(s) is non-refundable and will not be applied towards Tuition.

Payment of Fees

- 9. The Parents (individually and collectively) agree to pay VTT the Tuition and other fees set out in the tuition assessment issued to the Parents at the beginning of the school year. The current fee schedule is set out in the attached document entitled "Financial Information".
- 10. Tuition and other fees must be paid in full by March 1, 2012. If the Parents choose to pay the Tuition or other fees in instalments, they agree to pay the first instalment and provide post-dated cheques for the remaining consecutive instalments by March 1, 2012, with the first post dated cheque to be dated March 1, 2012.
- 11. All unpaid balances are immediately due. Any unpaid amounts owing to VTT will bear interest at the rate of 1.5% per month on the unpaid balance or 18% per annum, compounded annually, calculated from the date payment was due until payment is received.
- 12. The Parent(s) agree to pay any additional fees as may be assessed from time to time (e.g. for field trips). Payment of such additional fees will be due upon notice.

- 13. VTT reserves the right to terminate this Enrollment Contract if the Parents fail to pay any amount owing to VTT pursuant to this Enrollment Contract. Failure by the Parents to pay any amount owing under the Enrollment Contract may also result in VTT withholding grades, transcripts, and yearbooks.
- 14. If and to the extent VTT is required to enforce its rights to collect payment under this Enrollment Contract, the Parents will be liable for all costs, expenses, damages, and liabilities incurred by VTT in any action, suit or proceeding including any legal costs and expenses incurred by VTT in enforcing this Enrollment Contract.

Refund Policy

15. No portion of the Deposit, Tuition or other fees paid or owing will be refunded or waived in the event of the non-attendance, absence, withdrawal or expulsion of the Student from VTT.

Termination of Contract

- 16. The Parents agree that this Enrollment Contract is subject to the Parents and Student complying at all times with VTT's rules, regulations and policies, as in effect from time to time (which are available on the VTT website www.talmudtorah.com). Failure by the Parents or Student to comply with VTT's rules, regulations and policies will result in the termination of this Enrollment Contract and the Student' expulsion or withdrawal from VTT.
- 17. VTT may immediately terminate this Enrollment Contract if, in the opinion of the Head of School, the Parents or Student engage in conduct unreasonably disruptive to the operations of the school or engage in conduct contrary to the values of VTT.

General

- 18. This Enrollment Contract will be governed and interpreted in accordance with the laws of the Province of British Columbia, Canada.
- 19. In the event that any provision or part of this Enrollment Contract is deemed void or invalid by a Court of competent jurisdiction or other legal authority, the remaining provisions or parts will be and remain in full force and effect.
- 20. A waiver, express or implied, by VTT of any default of the Parent(s) in the observance or performance of this Enrollment Contract will not constitute or be construed as a waiver or condonation of any subsequent or other default.

21. This contract describes the Parents' entire Enrollment Contract with VTT. It supersedes and replaces any prior agreements or representations, whether oral or written. The Parents agree that there are no collateral contracts or agreements between the Parents and VTT, and that VTT has not made any representations to the Parents except as specifically set forth in this Enrollment Contract.

By signing this Enrollment Contract, the Parents (individually and collectively) agree to comply with the terms and conditions set out above in exchange for VTT's agreement to accept the Student for Enrollment in the 2012/2013 school year at VTT.
